ORDER

Change of Premises of the Institution

WHEREAS, in terms of Section 14/15 of the NCTE Act, 1993, recognition was granted to Tot Sol Educational Academy, Plot/Khasra No.-1372, Plot No. 340.341, Village- Arbalia, Post Office-Arbalia, Tehsil/Taluka-Baduria, Town/City-Baduria, District- North 24 Parganas, State- West Bengal, Pin Code-743437 for B.Ed. programme of two year duration with an intake of 50 students *vide* ERC Order No. F.ER-215.6.8/ERCAPP3969/ B.Ed./2016/47481 dated 25.06.2016 from the academic session 2017-2018, as per NCTE Regulations, 2014.

2. **AND WHEREAS**, further, in terms of Section 14/15 of the NCTE Act, 1993, recognition was granted to Tot Sol Educational Academy, Plot/Khasra No.-1372, Plot No. 340.341, Village- Arbalia, Post Office-Arbalia, Tehsil/Taluka-Baduria, Town/City-Baduria, District- North 24 Parganas, State- West Bengal, Pin Code-743437 for D.El.Ed. programme of two year duration with an intake of 50 students *vide* ERC Order No. F.ER-215.6.7/ERCAPP3960/D.El.Ed./2016/47497 dated 25.06.2016 from the academic session 2017-2018, as per NCTE Regulations, 2014.

3. **AND WHEREAS**, the application from the institution dated 06.03.2023 received in ERC on dated 13.03.2023 for shifting of institution from Plot/Khasra No.-1372, Plot No. 340.341, Village- Arbalia, Post Office-Arbalia, Tehsil/Taluka-Baduria, Town/City-Baduria, District- North 24 Parganas, State- West Bengal, Pin Code-743437 to Plot No. 300, 302, 234/286, 234/287, Village Mollapara & Nadibhag, P.O.-Kazipara, P.S. - Madhyamgram, District- North 24 Parganas Kolkata- 700125 was placed before ERC in its 329th (Emergent) meeting held from 30.06.2023 and the committee decided as under:-
